Dear St. Vincent Ferrer Parishioners:

I am pleased to provide you (on the back of this letter) with our Annual Parish Report for the fiscal year that ended June 30, 2007, with a comparison to the results from 2006. As you can see, we face a number of financial challenges here at St. Vincent Ferrer Parish.

The cost to keep our parish operating as a healthy and vibrant Catholic faith community continues to increase. Whenever possible, we have controlled our costs. This year, we even took the painful action of reducing staff. You can see these measures reflected in the Report, in that total expenses dropped by almost \$12,000 from 2006 to 2007. I thank everyone who participated in these cost-cutting efforts.

Income was only slightly higher this year compared to last year. We still had a deficit of well over \$100,000, and we had to take \$85,000 out of savings to meet expenses. I have called for a renewed focus on Stewardship at our parish to increase involvement and income. Our Development Commission is hard at work, revitalizing income-producing events like our festival, and finding new sources of income like our Mardi Gras evening and Bingo. Since our costs still exceed our income, we all have to work harder, and pray for more help and inspiration.

Offertory collections dropped by \$20,000 from the previous year. I ask every family to do what they can to remedy this in 2007 and 2008. **It is vitally important that our Sunday Offertory remain strong.** Your offertory gifts are the mainstay of our parish income, so please consider increasing your donations. Even better, call the parish office to make your donations by EFT – no checks to write, and it helps your parish.

I am grateful to everyone who has made St. Vincent Ferrer Parish a wonderful place to worship and grow in our faith. My God bless us with His love and grace as we look to the future together.
